Subject to obtaining all necessary unitholder and regulatory approvals, Sun Life BlackRock Canadian Equity Class will be merged into Sun Life BlackRock Canadian Equity Fund. If approved, the merger will be effective on or about June 5, 2020. The Fund is closed to purchases in new investment accounts effective at the close of business on February 26, 2020.

What does the fund invest in?


The Fund's investment objective is to seek capital appreciation through exposure to primarily Canadian equity securities by investing primarily in units of Sun Life BlackRock Canadian Equity Fund or its successor fund (the "underlying Trust Fund"). The Fund may invest up to 35% of the underlying Trust Fund's assets in foreign securities.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.



Risk rating

Sun Life Global Investments (Canada) Inc. has rated the volatility of this fund as Medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.



How has the fund performed?

This section tells you how Series AT5 shares of the fund have performed over the past 6 calendar years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

Year-by-year returns

This chart shows how Series AT5 shares of the fund have performed in each of the past 6 calendar years. The series dropped in value in 2 of the 6 years shown. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series AT5 units of the fund in a 3-month period over the past 6 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As at December 31, 2019, a person who invested \$1,000 in Series AT5 shares of the fund since inception now has \$1,630. This works out to an annual compound return of 7.9%.

Who is this fund for?	A word about tax
 Investors who: Seek a Canadian focused equity fund with broad sector diversification. Are long term investors. Are comfortable with medium investment risk. 	In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.
Do not invest in this fund unless you are willing to accept the potential loss of a portion of your investment or if you have a short-term investment horizon.	Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.
Series AT5 shares may be suitable for investors holding shares outside of a registered plan and wishing to receive monthly distributions.	

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series AT5 shares of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You have to choose a sales charge option when you buy shares of this series of the fund. Ask about the pros and cons of each option.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2019, the series' expenses were 1.98% of its value. This equals approximately \$20 for every \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own your fund. It is for the services and/or advice that your representative and/or their firm provide to you.

Sun Life Global Investments (Canada) Inc. pays the trailing commission to your firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

- Front end sales charge: 1.0% of the value of your investment each year. This equals \$10.00 each year for every \$1,000 invested.
- Deferred sales charge: 0.5% of the value of your investment each year. This equals \$5.00 each year for every \$1,000 invested.
- Low load sales charge: 0.5% of the value of your investment each year. This equals \$5.00 each year for every \$1,000 invested.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of this series of the fund.

Fee	What you pay	
Short-term trading fee	If you redeem or switch shares of the fund within 30 days of purchase, Sun Life Global Investments (Canada) Inc. may charge a short-term trading fee of 2.0% of the value of the shares redeemed or switched on behalf of the fund.	
Switch fee	Your firm may charge you up to 2.0% of the value of shares that you switch to another fund.	
NSF fee	Sun Life Global Investments (Canada) Inc. will charge you an NSF fee (\$30 for each returned item) should any cheque or purchase order be returned because of insufficient funds in your account.	
Courier or wire transfer fee	If you request that redemption proceeds be forwarded to you by courier or wire transfer, Sun Life Global Investments (Canada) Inc. may charge you for any costs incurred by Sun Life Global Investments (Canada) Inc. in connection with such delivery method.	

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts documents, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
