

What does the fund invest in?

"The Fund's investment objective is to seek long-term superior growth of capital by investing directly in equity securities of companies located in India or indirectly by investing in mutual funds (including exchange-traded funds) that invest in such securities. Until on or about December 15, 2020, the Fund will invest its assets primarily in equity securities of companies located in India through a "fund-of-fund" arrangement to facilitate investment in securities located in India. On or about December 15, 2020, the Fund will directly invest its assets primarily in equity securities of companies located in India through a "fund-of-fund" arrangement to facilitate investment in securities located in India. On or about December 15, 2020, the Fund will directly invest its assets primarily in equity securities of companies located in India. The Fund may also invest in Canadian equity securities with a focus on companies doing business in India, debt securities of Canadian issuers, American Depository Receipts, Global Depository Receipts or exchange-traded funds listed on stock exchanges in developed markets and euro convertible bonds issued by Indian corporations and other securities.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.



Risk rating

SLGI Asset Management Inc. has rated the volatility of this fund as High.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.



How has the fund performed?

This section tells you how Series DB securities of the fund have performed over the past 3 calendar years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

Year-by-year returns

This chart shows how Series DB securities of the fund have performed in each of the past 3 calendar years. The series dropped in value in 1 of the 3 years shown. Best and worst 3-month returns

Average return

As at August 31, 2020, a person who invested \$1,000 in Series DB securities of the fund since inception has \$1,137. This works out to an annual compound return of 3.3%.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series DB securities of the fund.

The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. Sales charges



There are no sales charges payable to your representative's firm for this series.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2020, the series' expenses were 2.17% of its value. This equals approximately \$22 for every \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own securities of the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

SLGI Asset Management Inc. pays the trailing commission to your firm. It is paid from the fund's management fee and is based on the value of your investment.

The trailing commission is 0.25% of the value of your investment each year. This equals \$2.50 each year for every \$1,000 invested.

3. Other fees

You may have to pay other fees when you buy, hold, redeem or switch securities of this series of the fund.

you redeem or switch securities of the fund within 30 days of purchase, SLGI Asset Management Inc. may charge a hort-term or excessive trading fee of 2.0% of the value of the securities redeemed or switched on behalf of the fund. you have been notified that you are a large investor and you wish to redeem or switch out an amount equal to: (a) 5,000,000 or more, if the Fund's total net assets are less than \$100,000,000 and the Fund has been available for sale for at

LGI Asset Management Inc. will charge you an NSF fee (\$30 for each returned item) should any cheque or purchase order e returned because of insufficient funds in your account.
you request that redemption proceeds be forwarded to you by courier or wire transfer, SLGI Asset Management Inc. may harge you for any costs incurred by SLGI Asset Management Inc. in connection with such delivery method.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts documents, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
