Effective on or about November 1, 2020, the management fee on this series will be lowered from 1.80% to 1.75%.

**What does the fund invest in?**

The Fund's investment objective is to achieve long-term capital appreciation with low volatility by investing primarily in a diversified portfolio of equity securities of issuers located anywhere in the world or indirectly by investing in mutual funds (including exchange-traded funds) that invest primarily in such securities. The Fund may invest in companies it believes to have above average earnings growth potential (growth companies), in stocks of companies it believes are undervalued (value companies), or in a combination of growth and value companies. The Fund may invest in companies of any size and may invest up to 100% of the Fund's assets in foreign securities.

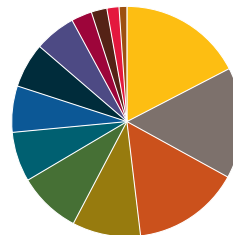

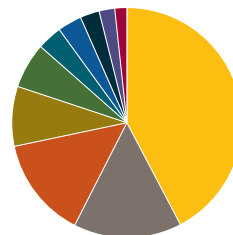

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

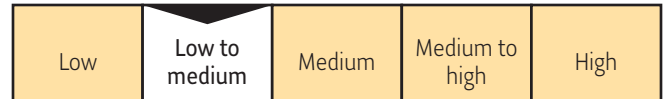
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

SLGI Asset Management Inc. has rated the volatility of this fund as **Low to medium**.

Because this is a new fund, the risk rating is only an estimate by SLGI Asset Management Inc. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

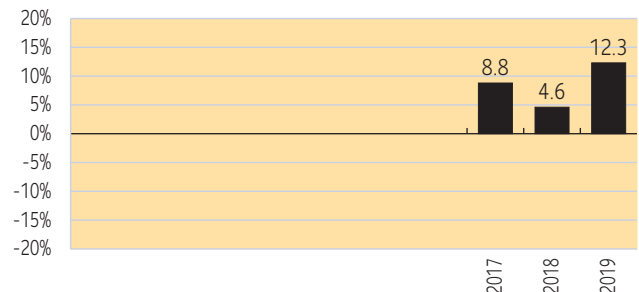
Like most mutual funds, this fund does not have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how Series T5 securities of the fund have performed over the past 3 calendar years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

#### Year-by-year returns

This chart shows how Series T5 securities of the fund have performed in each of the past 3 calendar years. The series did not drop in value in the last 3 years shown. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for Series T5 securities of the fund in a 3-month period over the past 3 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As at May 31, 2020, a person who invested \$1,000 in Series T5 securities of the fund since inception has \$1,300. This works out to an annual compound return of 6.3%.

### Who is this fund for?

#### Investors who:

- Seek to add global geographic diversification with less volatility compared to the Fund's benchmark (the MSCI All Country World Index C\$).
- Are long-term investors.
- Are comfortable with low to medium investment risk.

Do not invest in this fund unless you are willing to accept the potential loss of a portion of your investment or if you have a short-term investment horizon.

### A word about tax

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series T5 securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You have to choose a sales charge option when you buy securities of this series of the fund. Ask about the pros and cons of each option.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2019, the series' expenses were 2.34% of its value. This equals approximately \$23 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own securities of the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

SLGI Asset Management Inc. pays the trailing commission to your firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

- **Front end sales charge:** 1.0% of the value of your investment each year. This equals \$10.00 each year for every \$1,000 invested.
- **Deferred sales charge:** 0.5% of the value of your investment each year. This equals \$5.00 each year for every \$1,000 invested.
- **Low load sales charge:** 0.5% of the value of your investment each year. This equals \$5.00 each year for every \$1,000 invested.

## 3. Other fees

You may have to pay other fees when you buy, hold, redeem or switch securities of this series of the fund.

Fee	What you pay
<b>Short-term or excessive trading fee</b>	If you redeem or switch securities of the fund within 30 days of purchase, SLGI Asset Management Inc. may charge a short-term or excessive trading fee of 2.0% of the value of the securities redeemed or switched on behalf of the fund.
<b>Large redemption penalties</b>	If you have been notified that you are a large investor and you wish to redeem or switch out an amount equal to: (a) \$5,000,000 or more, if the Fund's total net assets are less than \$100,000,000 and the Fund has been available for sale for at least two (2) years; or (b) more than 5% of the Fund's total net assets, if the Fund's total net assets are greater than or equal to \$100,000,000 (either is considered a "Large Redemption"), you will pay 1% of the NAV of the securities redeemed or switched if you do not provide the required five (5) business days' notice prior to completing the transaction. If the Large Redemption would be subject to both a large redemption penalty and a short-term or excessive trading fee, only the short-term or excessive trading fee will apply.
<b>Switch fee</b>	Your firm may charge you up to 2.0% of the value of securities that you switch to securities of another fund.
<b>NSF fee</b>	SLGI Asset Management Inc. will charge you an NSF fee (\$30 for each returned item) should any cheque or purchase order be returned because of insufficient funds in your account.
<b>Courier or wire transfer fee</b>	If you request that redemption proceeds be forwarded to you by courier or wire transfer, SLGI Asset Management Inc. may charge you for any costs incurred by SLGI Asset Management Inc. in connection with such delivery method.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts documents, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
